

PRIVACY POLICY AND NOTICE – FINTECH GLOBAL CENTER

1. Data Controller

This website is operated by **Fintech Global Center, Inc. (FGCI)** and **Fintech Global Center Private Limited (FGCPL)**, collectively referred to as “**FGC.**” FGC acts as the **Data Controller** for any personal information submitted through this website in accordance with the organization’s Personal Data Protection Policy.

2. Personal Data Collected

FGC collects personal data **only when you voluntarily submit the Contact Us form.** The data elements collected are:

- Your Name
- Email Address
- Message text provided by you

FGC does not collect any other categories of visitor information and does not operate anonymous tracking mechanisms.

3. Purpose of Processing

Personal data received through the Contact Us form is processed **solely** for the following purposes:

- To respond to your inquiry or request.
- To communicate regarding fintech services, projects, or collaborations.
- To maintain reasonable records of correspondence for legal or contractual necessity.

FGC does not use this data to create marketing lists or share it for unrelated purposes.

4. Lawful and Jurisdictional Alignment

FGC demonstrates compliance with applicable privacy frameworks, including:

- **United States – Privacy Act 1974 and relevant federal or state privacy laws:** use limited to the purpose disclosed above.
- **India – Digital Personal Data Protection Act 2023 (DPDP Act):** processing based on consent and service inquiry necessity.
- **United Kingdom – UK GDPR and Data Protection Act 2018:** processing for legitimate interests of business communication.

Where more than one jurisdictional requirement may apply, FGC follows the **most stringent applicable standard** as described in the internal policy.

5. Disclosure to Third Parties

FGC does not disclose visitor personal data except:

- To authorized internal personnel handling the inquiry.
- To contracted service providers assisting communication, subject to confidentiality obligations.
- When required by law, regulator, court, or law enforcement agency.

All disclosures occur on a **need-to-know basis**.

6. Retention

Name, email address, and message correspondence are retained **only as long as necessary** to fulfil the inquiry and in line with FGC's retention rules defined in the Personal Data Protection Policy. Visitors' data is securely deleted upon closure of the purpose unless legal obligation requires otherwise.

7. Rights of Website Visitors

Subject to applicable laws, you may contact FGC to exercise the following rights:

- Obtain confirmation and **access** to your personal data.
- Request **rectification** of inaccurate data.
- Request **erasure/deletion** where no legal or contractual obligation exists.
- **Withdraw consent** for consent-based processing.
- **Complain** to the applicable authority in India, the US, or the UK if dissatisfied.

8. Cookies and Tracking

FGC uses solely the correspondence details provided by you in the Contact Us form and does not employ any separate tracking tools or technologies to identify visitors.
